

# UCC PERIODIC SUPPORT

All authorized ministers, ordained, licensed, commission (active or retired) are required to attend one of the following Periodic Support Consultations at least once every two years. The purpose of the consultation is to provide support and encourage ministers' personal and vocational development and to provide an occasion for reflection and feedback on the practice of ministry. They also provide opportunities to review and strengthen relationships among the covenantal partners. To meet the standards set by the United Church of Christ Manual on Ministry, the Northwest Ohio Association Church and Ministry Team is expected to conduct these consultations for all authorized ministers with standing in the Association.

All authorized ministers need to participate in a Periodic Support Consultation to meet these standards, as well as any pastor new to the Association. This also includes retired ministers. (The exception to attending this Periodic Support Consultation would be if you are regularly attending an Excellence in Ministry Group. If so, please note on Registration and return to the Association Office.)



If you are unable to attend one of the consultations and as a result will not be able to meet the standard that is set, you can either attend a consultation in a neighboring association or complete the exemption application form on page 2.

**Exemption Application Form**

To maintain good standing or a good covenanted relationship in the Northwest Ohio Association (NWOA), all authorized persons who hold standing in the NWOA or serve in NWOA must fulfill the following requirements. Exemptions shall be granted on an individual basis to an authorized minister for whom it is determined by the NWOA Church and Ministry Team to have health issues that preclude them from participation, are unable to attend a consultation or training event, or another reason that is determined by the NWOA Church and Ministry Team to be acceptable. If the requirements are not met, and no exemption was granted, standing and the covenanted relationship with the NWOA will be in jeopardy. The local church will be kept notified of the authorized person's current status.

**1. Periodic Support Consultations:** Participation in a "Periodic Support Consultation" is required every two years for all authorized persons who hold standing in NWOA or serve in NWOA unless you regularly attend and *Excellence in Ministry* Group."

**2. Boundary Training:** "Boundary Training" is required every two years for all authorized persons who hold standing in NWOA or serve in NWOA.
