Due to health reasons, our custodian, Gib Adams, resigned and we thank him for his time with us. I thank you for this opportunity and the joy of being with you for almost 19 years since I began serving you as NWOA Association Minister. I appreciate invitations to be part of worship services of our NWOA churches.

#### NWOA Moderator's Report 2024

Due to the retirement of Rev. Jim Brehler, I have assumed the role of Moderator for the remainder of Jim's term in 2024. My church membership is with Bloomville UCC, where I served many years as Consistory President. However, I now live in a beautiful senior living facility in St. Mary's and made this move to be closer to my son after my husband's death. I served on the Association Cabinet several years ago as vice-moderator. More recently I have served on the Human Resources Committee, and as Sandusky Valley regional representative. Please be patient with me as I navigate these new waters as Moderator with you.

#### SUMMARY OF NWOA CABINET ACTIVITY 2023-2024 PASTOR JAY SCOTT

#### May 2023

- The Cabinet received the annual outside audit report from its hired auditor, Mr. Ron Coon, who said the Association's financial foot is "solid and fiscally sound."
- A bid was accepted from a vendor for the re-sealing of the parking lot at the Association headquarters.
- Discussion was held regarding the pros and cons of in-person vs. online meetings. The Cabinet decided to meet in person in May, and online for the rest of the year.

#### September 2023

- The Cabinet adopted a formal policy for the receipt of cash and in-kind donations. The policy outlines what donations are routine and can be accepted by the Association Minister or the office staff, and what donations require formal acceptance by the Cabinet. This policy was recommended by the outside auditor.
- Rev. Busch, Association Minister, announced the closing of Faith Community UCC in Maumee.

#### November 2023

- The Cabinet approved a 4% salary increase for all Association staff beginning in 2025, and added this to the proposed budget.
- The Human Resources Committee reviewed the recent formal evaluation of Rev. Busch.
  Committee Chairman David Orr stated there was general agreement that Rev. Busch's gifts of
  ministry and care to churches and pastors is greatly appreciated. He said the evaluations
  submitted by participants indicated a need for leadership regarding the vision and future of the
  Association, and he added this is a shared responsibility with the Cabinet.
- A brief discussion of possible proposed changes to the NWOA constitution were discussed. More formal discussions were planned for future meetings.

#### January 2024

- The Finance Committee reported income and expenses would end the year balanced for the first time in several years.
- The Cabinet approved the Association Minister's housing allowance at \$12,000.
- A committee of Jay Scott, Ed Heilman, Betty Rettig, Garland Gates and Dan Busch worked on a series of revisions to the Association's constitution, including the elimination of "regions" and the establishment of at-large members of the Cabinet. Busch reviewed the proposed changes. Discussion about the use of at-large members led to a consensus that the Nominating Committee should be advised by the Cabinet to recruit these members from a variety of locations within the Association boundary. The Cabinet voted to recommend these changes to the Annual Meeting.

Moderator Jim Brehler announced his retirement from pastoral ministry, and that he is moving
to Michigan, thus creating a vacancy for the position of Moderator. The Cabinet appointed
Vice-moderator Peggy George to finish Brehler's term as Moderator, and appointed Jay Scott
to finish George's term as Vice-moderator. These appointments created a vacancy for Cabinet
Secretary. A search for a new secretary will begin.

#### February 2024

 Voting via e-mail by the Cabinet resulted in the following decisions: A technical change to the proposed constitution changes was approved, and Rev. Darla Metz was appointed to finish Jay Scott's term as Cabinet Secretary.

#### March 2024

- Finance Committee reported income and expenses have balanced. After a review of our taxes by the Seneca County Auditor, the property taxes for the Association have been reduced by 2/3. Office staff will receive a 4% increase.
- Lay School has 12 students enrolled for the Fall semester.

#### The Minutes of the 60<sup>th</sup> Annual Meeting of the Northwest Ohio Association of the United Church of Christ April 29, 2023

After several years of this meeting being conducted online due to a worldwide pandemic, the people of the Northwest Ohio Association were invited to meet in person. Although some chose to join the meeting via the internet, we praise God that in-person meeting was finally possible.

#### **Call to Order**

Moderator Doug Ricci called the Annual Meeting to order, and welcomed those in attendance. Ricci also thanked everyone who helped plan and organize the meeting, and thanked the members of St. Paul UCC in Wapakoneta for hosting the meeting. Ricci declared a quorum to be present, allowing business to be conducted.

#### **Opening Worship**

The opening worship service was led by Rev. Dan Busch, Rev. Jim Brehler, and Rev. Mark Bishop. The offering for the day is designated for Grace Community Center in Toledo, per the NWOA Cabinet.

#### Adoption of the Agenda

Moderator Ricci reviewed who was eligible to vote, described the process for participation, and asked for a motion to approve the agenda as presented. The motion was offered by Dave Voll, St John's Holgate, seconded by Garland Gates, Steuben, and carried.

#### **Appointments**

Ricci announced the appointment of Garland Gates as the parliamentarian, and announced Cabinet Secretary Jay Scott would be taking the minutes of the Annual Meeting.

#### **Adoption of Standing Rules**

The Standing Rules of the Annual Meeting were presented in the meeting book. Brad McKibben, Trinity Upper Sandusky, moved to adopt the Standing Rules, seconded by Dave Plant, Defiance. The motion carried.

#### Adoption of the Minutes from the 2022 Annual Meeting

The minutes of the 2022 NWOA Annual Meeting were accepted on a motion by Jay Scott, Emanuel Upper Sandusky, seconded by Amy Kinney, St. John's Fostoria. The motion carried.

#### Introduction of Guests, and the Granting of Voice to Guests

Rev. Dan Busch introduced the following guests: Rev. George Graham, Rev. David Long-Higgins, Ms. Elaine Page, and Mr. Kevin Gehres.

Ken Daniels, 1<sup>st</sup> Marion, moved to grant voice to the guests listed, seconded by Ron Wilch, Emanuel Upper Sandusky. The motion carried.

#### Recognition of Persons New to the Association, and Members in Discernment

Rev. Ronda Hainer of the Church and Ministry Team, introduced those new to the Association, and those who are now Members in Discernment. Rev. Busch introduced newly ordained minister Rev. Mike Ebersole, who addressed the Annual Meeting.

#### **Greetings and Comments**

Remarks were heard from the following: Heartland Conference Minister Rev. David Long-Higgins, and Executive Director of Outdoor Ministry Ms. Jill Frye.

#### **Nominations and Elections**

Mary Ann Ewing, representing the Nominating Committee, presented the nominations as outlined in the Annual Meeting book. There were no additional nominations offered from the floor.

The Nominating Committee moved to close nominations and cast a unanimous vote for the nominees, all of whom were unopposed. No second was required. The motion carried.

#### Financial Report for 2022, 2023, and 2024

Treasurer Dian Ewald presented the financial reports, which were also published in the Annual Meeting book. She noted that the audit of 2022 records is not yet completed.

Ewald moved on behalf of the Cabinet to accept the 2022 unaudited report. No second was required. The motion carried.

Ewald moved on behalf of the Cabinet to adopt the revised 2023 budget. No second was required. The motion carried.

Ewald moved on behalf of the Cabinet to adopt the 2024 budget. No second was required. The motion carried.

#### **Recognitions of Anniversaries of Churches and Ministries**

Attention was drawn to the Annual Meeting book and the list of churches and ministries listed for special recognition.

Special recognition was also given to churches who achieved "5 for 5" status by contributing to all five of the UCC special offerings during the past year, as well as those churches that maintained or increased their giving to the "Our Churches Wider Mission" offering.

#### **Ministry Team Annual Reports**

Ricci directed the meeting's attention to the annual reports of the eight ministry teams of the Association. Barbara Osborn, Bascom moved to approve the receiving of all of the reports, seconded by Ivory Stahl, Bascom. The motion carried.

#### Video

The Annual Meeting viewed a video about solar lamps being distributed in Ukraine.

#### **Special Recognition**

Rev. Busch called Association Office Administrator Joan Davidson to the stage to give her recognition for 25 years of service to the NWOA. He presented her with a gift.

#### Video

The Annual Meeting viewed a video from Uplands Village.

#### **Keynote Speaker**

The keynote address was delivered by Rev. George Graham of the Council for Health and Human Service Ministries.

#### **Mission Happenings**

Presentations from the following missions/ministries were offered: Grace Community Center – Ms. Elaine Tate-Page, El Salvador Partnership – John Gilberg, Emanuel UCC (Upper Sandusky) – Pastor Jay Scott, Back Bay Mission – Rev. Jeanette Tangeman; Lynn and Mary Ann Ewing, Heartland Conference Disaster Ministry – Mr. Kevin Gehres.

#### Closing Celebration, Announcements, Amenities, Leadership Installation

Rev. Busch gave recognition to the newly elected officers and ministry team members, then led the Annual Meeting in a closing worship. Busch led the Annual Meeting in a rite of installation to their respective positions. Moderator Ricci entertained a motion by Garland Gates, Steuben, to adopt the following resolution:

"Be it resolved that the Northwest Ohio Association gathered in person at St. Paul United Church of Christ, Wapakoneta, Ohio, and through Zoom on April 29, 2023, gives thanks to God for this day celebrating 'Missions: Making All Things.' Be it further resolved that we are witnesses to a resurrection faith that affirms and proclaims that we remember that we are a community of faith that is challenged by our theme to be people of 'MISSIONS,' believing that through us God is 'MAKING ALL THINGS NEW.' 'Empowered by the Holy Spirit we are called to connect, equip, and support our faith communities to grow as faithful disciples and responsible stewards, following Jesus' call to extravagantly love all God's children and creation.' Be it further resolved, 'Answering God's call to build a just world for all, we commit in our shared life to: Live the love, unity, and compassion of Jesus; Collaborate to mutually share resources; Communicate with openness and transparency; Empower generous and responsible stewardship; and Honor God's diverse gifts among us in all settings.' Be it further resolved that Northwest Ohio Association expresses gratitude and appreciation to all who have organized, guided, inspired, encouraged, and resourced our 60th Annual Meeting as we gathered together to remember that we acknowledge God is calling us 'MISSIONS: MAKING ALL THINGS NEW' to the honor and glory of God."

The motion was seconded by Dave Voll, St John's Holgate, and carried.

Ricci then extended another round of thanks to those who planned and hosted the Annual Meeting, and announced that the 61st Annual Meeting would be held on April 27, 2024 at St. Stephen's UCC in Sandusky.

Following an "exchange of the gavel" passing the office of moderator to newly elected Rev. Jim Brehler, a motion to adjourn was offered by Darla Metz, Republic, and seconded by Terra Connors, Sycamore. The motion carried.
