Recognizing God's love for all, we listen to each other, and seek to enable each other to be all that God intends.

We are the Body of Christ: a community of communities that freely shares of itself with others—a community that will shatter the complacency of this earth and bring God's intended peace and justice to all.

Church and Ministry Team

The Church and Ministry Team relates to the Northwest Ohio Association, the Heartland Conference and the wider setting of the church. We focus on relationships in the following ways: (1) this team works in collaboration with one another as each member brings unique perspectives and gifts (2) we engage those wishing to become authorized ministers, both lay and ordained. (3) we also work with the local church. Authorized ministers meet with us when they are new to the association or are transferring to another congregation. This can be a way of assuring those in a pastoral role that they are not alone. This helps these individuals to be better able to serve a local congregation because they have the association minister and the Church and Ministry Team to encourage them. These connections are meant to remind us that we are all in covenant with each other. None of the various bodies speak for one another, but we speak to one another to help make the body of Christ as strong as it can be.

There are two major areas that the Church and Ministry Team is charged with. When there are people considering becoming an authorized minister, the Church and Ministry Team helps them discern how their sense of call matches with the larger church's sense of servant ministry. This is a thorough process and as one former member of our team would say, "it takes as long as it takes." We walk alongside those who are Members in Discernment by offering encouragement, reflection and challenging areas that might require growth. This exhaustive process is meant to assure local congregations that those serving as authorized ministers are held to a high standard of preparation and the character necessary for faithful and fruitful ministry.

Another vital piece of our work is staying connected with our authorized ministers. This is done in a variety of ways. Pastoral leaders are asked to complete an annual review and we also encourage them to participate in Excellence in Ministry/Communities of Practice. Each October we recognize retired clergy at a luncheon.

Pastoral Relations Working Group Church and Ministry Team

The Pastoral Relations sub-committee of Church and Ministry seeks to keep connection with the authorized ministers of the Association. Authorized ministers are required to complete a yearly written periodic review and attend a Periodic Support Training every two years to remain in good standing. Authorized Ministers who participate in a Community of Practice are exempt from the biennial Periodic Support Training. We also host a luncheon for our retired clergy every year.

The Periodic Support Trainings were held in March and in October. The March training was at St. John's UCC in Milan and was in-person only. The October training was at the Association Office and was offered as a hybrid event. The Retired Clergy Luncheon was held at Parkvue Place in Sandusky with about 60 attendees. <u>Discernment (Formerly In-Care) Working Group</u> <u>Church and Ministry Team</u>

A Member in Discernment (MiD) is a UCC member who has sensed a call to serve as an ordained minister in our denomination. An individual who senses this call must first be supported by their home church and apply to the Church and Ministry Committee to be admitted to the Discernment Process.

"The Discernment Process is a time of interactive and caring discernment of call." (Discernment Manual - 2020 Revision). This is a formalized process with course requirements and protocols that must be completed by the MiD. The Discernment Working Group works with the MiD to provide support and encouragement during this process. Each MiD is assigned an advisor who provides support, advice, and guidance. In addition, the Discernment Working Group interviews each MiD annually. This review is primarily a conversation in which the MiD shares where they are on the path of discernment. In nearly every case, the Discernment Advisor attends these reviews.

The Discernment Working Group acts on behalf of the Church and Ministry Committee and ultimately on behalf of the whole of the UCC. Following successful completion of the required courses and protocols, the Discernment Working Group presents the MiD to the Church and Ministry Committee for approval of ordination pending a call to a congregation.

One project that has occupied our time this year is a review of course requirements that lead to ordination. The Association of Theological Schools, the body that accredits seminaries, provides guidelines for seminary curricula. The current guidelines include cultural issues that face our nation and, in particular, our congregations. Seminaries have responded to these guidelines by revising their curricula. The goal of our working group is to ensure that our course requirements for ordination address these changes. We are very early in the process and are in no way ready to recommend revisions. In addition, any revisions to the required course list will not impact MiDs currently in the Discernment Process.

There are currently seven Members in Discernment – see the table in the sequel. Two former MiDs, Don Clark and Ryan Shields, are no longer in the process.

I thank the local churches, pastors, and advisors that support our MiDs. Members of the Discernment Working Group continue to be impressed with the dedication and talents of these who have heeded God's call to ministry. What a blessing they are to our Association.

El Salvador Coordinating Team

Iglesia Luterana Salvadorena - Our Global Partner

Friends: The El Salvador Coordinating Team is still in existence but has not gathered since the CoVid Pandemic hit two years ago. In the meantime, this is an update on what is happening in El Salvador. The country is much safer for the local citizens because of the arrest of thousands of gang members by orders of Mr. Bukele, the president of El Salvador. Several new jails were built and anyone suspected of belonging to a gang was arrested and put in jail. This is good for the citizens, but many non-gang members have been arrested and were also put in jail. The people were those who were opposed to the government's policies and were also arrested. The president suspended the supreme court and changed the election policy of presidents only serving for on five-year term. Mr. Bukele is now in his second term and may continue for a long time into the future. He has turned the government into an autocratic form of rule. The democratic form of government was established by the U.N. after their civil ward ended in 1992. It has survived until Mr. Bukele was elected president five years ago.

According to an article in the February 16 edition of THE WEEK magazine, "Mr. Bukele has been credited with crushing the two major gangs of El Salvador after filling the streets with soldiers and ordered mass arrests. This was documented in widely distributed photos of thousands of shirtless, tattooed suspects. He jailed more than 70,000 people, including 7,000 who had no gang connection and were later released." There are still some opposition leaders, non-gang members, who are still in jail.

Rev. Dan Busch and I visited El Salvador last October and found that the Lutheran Church is heading for a change in its leadership. Bishop Gomez is retiring as Bishop of the Church. He has served as bishop for over 38 years. A new bishop will be elected soon. He or she will be installed January 1, 2025. There are four candidates for the bishop's position.

We are still looking for a person or persons who can serve as El Salvador Coordinators. Thank you for your support and we pray this partnership will continue. Contact John and Joyce Gilberg at 419-629-2947 or 419-230-8177.

Community of Practice Program

And let us consider how to spur one another on to love and good deeds. . . - Hebrews 10:24 NIV

"Communities of Practice" is the new name for the program formerly known as "Excellence in Ministry." It was adopted to be in keeping with the way the program is now known throughout the United Church of Christ. Community of Practice groups offer ministers opportunities to learn from one another, receive mutual support from colleagues, and grow in their vocations. Groups, generally meet, in person or by Zoom, for at least two hours each month from September through May.

Forty-six members and leaders currently participate in Northwest Ohio Association Community of Practice groups. Rev. Busch's strong support helps to continue the high percentage of pastors involved in the program. Each year groups go through some realignment as ministers join the program, move, or retire. Because of these changes, the number of active groups went from eight to seven this year with participants of the eighth group joining others.

Facilitators provide leadership for each group. All facilitators meet quarterly for training, program administration, and mutual support. Facilitators for 2023-24 are Wendy Schindler Chasney, Ken Daniel, Joel Fetter, Ed Heilman, Darla Metz, Margaret Mills, David Orr, and Becky Erb Strang. Ed Heilman ended his work as facilitator when groups were consolidated. Because of other responsibilities, Ken Daniel will conclude his co-leadership of the group for newer pastors at the end of May. Darla Metz will continue as the group's co-facilitator and will be joined by Tom Kagy. Both Ed and Ken have served as Community of Practice facilitators since the program was introduced in the association. We are thankful for their long service and grateful for the continuing work of all of the group leaders.

Congregations are asked to include participation in a Community of Practice group in their call agreements for new pastors and to encourage those currently serving to join a group. Setting aside funds for the annual participation fee is a concrete demonstration of a church's commitment to the personal and professional health of their pastor.

Applications are available from the Northwest Ohio Association office and may be submitted at any time.

Lay School Board

The aim of the Lay School of Religion Program has been to maintain quality instruction, to create an atmosphere for Christian fellowship and dialogue, and to encourage growth in faith and understanding so as to enhance the local church's efforts to develop deeper and stronger faith communities for nurture, witness, mission and leadership. All persons are welcome to enroll in the Lay School of Religion Program for personal enrichment.
